## Certificate of Insurance

a. the Insurer shall refund the excess of premium actually paid by the Insured over the proportional premium for the expired time, but in no event shall the proportional premium for the expired time to be deemed to be less than any minimum retained premium specified; and

b. the refund shall accompany the notice unless the premium is subject to adjustment or determination as to amount, in which case the refund shall be made as soon as practicable.

3. The refund may be made by money, postal or express company money order, or cheque payable at par.

4. The fifteen (15) days mentioned in clause (a) of sub-paragraph (1) of this condition start to run on the day following the receipt of the registered letter at the post office to which it is addressed.
